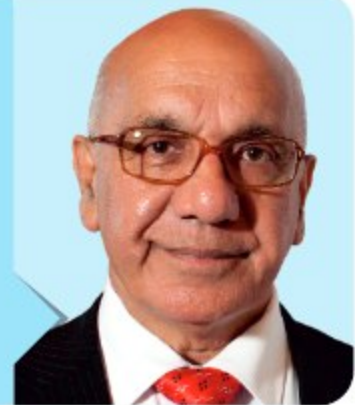

BRIEF HISTORY OF ENGLAND AND BRITISH PARLIAMENT

England became inhabited more than 800,000 years ago, as the discovery of stone tools and footprints at Happisburgh in Norfolk has indicated. The earliest evidence for early modern humans in Northwestern Europe, a jawbone discovered in Devon at Kents Cavern in 1927, was re-dated in 2011 to between 41,000 and 44,000 years old. Continuous human habitation in England dates to around 13,000 years ago, at the end of the Last Glacial Period. The region has numerous remains from the Mesolithic, Neolithic and Bronze Age, such as Stonehenge and Avebury. In the Iron Age, all of Britain south of the Firth of Forth was inhabited by the Celtic people known as the Britons, including some Belgic tribes (e.g. the Atrebates, the Catuvellauni, the Trinovantes, etc.) in the south east. In AD 43 the Roman conquest of Britain began; the Romans maintained control of their province of Britannia until the early 5th century. The end of Roman rule in Britain facilitated the Anglo-Saxon settlement of Britain, which historians often regard as the origin of England and of the English people. The Anglo-Saxons, a collection of various Germanic peoples, established several kingdoms that became the primary powers in present-day England and parts of southern Scotland. They introduced the Old English language, which largely displaced the previous Brittonic language. The Anglo-Saxons warred with British successor states in western Britain and the Hen Ogledd (Old North; the Brittonic-speaking parts of northern Britain), as well as with each other. Raids by Vikings became frequent after about AD 800, and the Norsemen settled in large parts of what is now England. During this period, several rulers attempted to unite the various Anglo-Saxon kingdoms, an effort that led to the emergence of the Kingdom of England by the 10th century.

After Caesar's expeditions, the Romans began a serious and sustained attempt to conquer Britain in AD 43, at the behest of Emperor Claudius. They landed in Kent with four legions and defeated two armies led by the kings of the Catuvellauni tribe, Caratacus and Togodumnus, in battles at the Medway and the Thames. Togodumnus was killed, and Caratacus fled to Wales. The Roman force, led by Aulus Plautius, waited for Claudius to come and lead the final march on the Catuvellauni capital at Camulodunum (modern Colchester), before he returned to Rome for his triumph. The Catuvellauni held sway over most of the southeastern corner of England; eleven local rulers surrendered, a number of client kingdoms were established, and the rest became a Roman province with Camulodunum as its capital. Over the next four years, the territory was consolidated and the future emperor Vespasian led a campaign into the Southwest where he subjugated two more tribes. By AD 54 the border had been pushed back to the Severn and the Trent, and campaigns were underway to subjugate Northern England and Wales. But in AD 60, under the leadership of the warrior-queen Boudicca, the tribes rebelled against the Romans.

The Norman Conquest led to a profound change in the history of the English state. William ordered the compilation of the Domesday Book, a survey of the entire population and their lands and property for tax purposes, which reveals that within 20 years of the conquest the English ruling class had been almost entirely dispossessed and replaced by Norman landholders, who monopolised all senior positions in the government and the Church. William and his nobles spoke and conducted court in Norman French, in both Normandy and England. The use of the Anglo-Norman language by the aristocracy endured for centuries and left an indelible mark in the development of modern English. Upon being crowned, on Christmas Day 1066, William immediately began consolidating his power. By 1067, he faced revolts on all sides and spent four years crushing them. He then imposed his superiority over Scotland and Wales, forcing them to recognise him as overlord.

The English Middle Ages were characterised by civil war, international war, occasional insurrection, and widespread political intrigue among the aristocratic and monarchic elite. England was more than self-sufficient in cereals, dairy products, beef and mutton. Its international economy was based on wool trade, in which wool from the sheepwalks of northern England was exported to the textile cities of Flanders, where it was worked into cloth. Medieval foreign

policy was as much shaped by relations with the Flemish textile industry as it was by dynastic adventures in western France. An English textile industry was established in the 15th century, providing the basis for rapid English capital accumulation.

Henry I, the fourth son of William I the Conqueror, succeeded his elder brother William II as King of England in 1100. Henry was also known as "Henry Beauclerc" because he received a formal education, unlike his older brother and heir apparent William who got practical training to be king. Henry worked hard to reform and stabilise the country and smooth the differences between the Anglo-Saxon and Anglo-Norman societies. Henry I had required the leading barons, ecclesiastics and officials in Normandy and England, to take an oath to accept Matilda (also known as Empress Maud, Henry I's daughter) as his heir. England was far less than enthusiastic to accept an outsider, and a woman, as their ruler.



There is some evidence that Henry was unsure of his own hopes and the oath to make Matilda his heir. Probably Henry hoped Matilda would have a son and step aside as Queen Mother. Upon Henry's death, the Norman and English barons ignored Matilda's claim to the throne, and thus through a series of decisions, Stephen, Henry's favourite nephew, was welcomed by many in England and Normandy as their new king. On 22 December 1135, Stephen was anointed king with implicit support by the church and nation. Matilda and her own son waited in France until she sparked the civil war from 1139 to 1153 known as the Anarchy. He met their leaders along with their French and Scot allies at Runnymede, near London on 15 June 1215 to seal the Great Charter (Magna Carta in Latin), which imposed legal limits on the king's personal powers. But as soon as hostilities ceased, John received approval from the Pope to break his word because he had made it under duress. This provoked the First Barons' War and a French invasion by Prince Louis of France invited by a majority of the English barons to replace John as king in London in May 1216. John travelled around the country to oppose the rebel forces, directing, among other operations, a two-month siege of the rebel-held Rochester Castle.

John's son, Henry III, was only 9 years old when he became king (1216–1272). He spent much of his reign fighting the barons over Magna Carta and the royal rights, and was eventually forced to call the first "parliament" in 1264. He was also unsuccessful on the continent, where he endeavoured to re-establish English control over Normandy, Anjou, and Aquitaine. The reign of Edward I (reigned 1272–1307) was rather more successful. Edward enacted numerous laws strengthening the powers of his government and he summoned the first officially sanctioned Parliaments of England (such as his Model Parliament). He conquered Wales and attempted to use a succession dispute to gain control of the Kingdom of Scotland, though this developed into a costly and drawn-out military campaign.

Edward I is also known for his policies first persecuting Jews, particularly the 1275 Statute of the Jewry. This banned Jews from their previous role in making loans, and demanded that they work as merchants, farmers, craftsmen or soldiers. This was unrealistic, and failed. Edward's solution was to expel Jews from England. With Henry VII's accession to the throne in 1485, the Wars of the Roses came to an end, and Tudors would continue to rule England for 118

years. Traditionally, the Battle of Bosworth Field is considered to mark the end of the Middle Ages in England, although Henry did not introduce any new concept of monarchy, and for most of his reign his hold on power was tenuous. He claimed the throne by conquest and God's judgement in battle. Parliament quickly recognised him as king, but the Yorkists were far from defeated. Nonetheless, he married Edward IV's eldest daughter Elizabeth in January 1486, thereby uniting the houses of York and Lancaster.

In 1215, King John agreed to limit his own powers over his subjects according to the terms of Magna Carta. To gain the consent of the political community, English kings began summoning Parliaments to approve taxation and to enact statutes. Gradually, Parliament's authority expanded at the expense of royal power. The Elizabethan era was the epoch in English history of Queen Elizabeth I's reign (1558–1603). Historians often depict it as the golden age in English history. The symbol of Britannia was first used in 1572 and often thereafter to mark the Elizabethan age as a renaissance that inspired national pride through classical ideals, international expansion, and naval triumph over the hated Spanish foe. From 1603, the English and Scottish kingdoms were ruled by a single sovereign in the Union of the Crowns. From 1649 to 1660, the tradition of monarchy was broken by the republican Commonwealth of England, which followed the Wars of the Three Kingdoms. Following the installation of William and Mary as co-monarchs in the Glorious Revolution, a constitutional monarchy was established with power shifting to Parliament. The Bill of Rights 1689, and its Scottish counterpart the Claim of Right Act 1689, further curtailed the power of the monarchy and excluded Roman Catholics from succession to the throne.

In 1707, the kingdoms of England and Scotland were merged to create the Kingdom of Great Britain, and in 1801, the Kingdom of Ireland joined to create the United Kingdom of Great Britain and Ireland. The British monarch was the nominal head of the vast British Empire, which covered a quarter of the world's land area at its greatest extent in 1921. After the 1707 Acts of Union- In 1714, Queen Anne was succeeded by her second cousin, and Sophia's son, George I, Elector of Hanover, who consolidated his position by defeating Jacobite rebellions in 1715 and 1719. The new monarch was less active in government than many of his British predecessors, but retained





control over his German kingdoms, with which Britain was now in personal union. Power shifted towards George's ministers, especially to Sir Robert Walpole, who is often considered the first British prime minister, although the title was not then in use.

In 1834, William dismissed the Whig Prime Minister, William Lamb, 2nd Viscount Melbourne, and appointed a Tory, Sir Robert Peel. In the ensuing elections, however, Peel lost. The king had no choice but to recall Lord Melbourne. During William IV's reign, the Reform Act



1832, which reformed parliamentary representation, was passed. Together with others passed later in the century, the Act led to an expansion of the electoral franchise and the rise of the House of Commons as the most important branch of Parliament. The final transition to a constitutional monarchy was made during the long reign of William IV's successor, Victoria. The Victorian era was marked by great cultural change, technological progress, and the establishment of the United Kingdom as one of the world's foremost powers. In recognition of British rule over India, Victoria was declared Empress of India in 1876. However, her reign was also marked by increased support for the republican movement, due in part to Victoria's permanent mourning and lengthy period of seclusion following the death of her husband in 1861. Victoria's son, Edward VII, became the first monarch of the House of Saxe-Coburg and Gotha in 1901. In 1917, the next monarch, George V, changed "Saxe-Coburg and Gotha" to "Windsor" in response to the anti-German sympathies aroused by the First World War. George V's reign was marked by the separation of Ireland into Northern Ireland, which remained a part of the United Kingdom, and the Irish Free State, an independent nation, in 1922. At first, every member of the Commonwealth retained the same monarch as the United Kingdom, but when the Dominion of India became a republic in 1950, it would no longer share in a common monarchy.

Elizabeth II as Elizabeth Alexandra Mary from 21 April 1926–8 September 2022 was Queen of the United Kingdom and other Commonwealth realms from 6 February 1952 until her death in 2022. She was queen regnant of 32 sovereign states during her lifetime and remained the monarch of 15 realms by the time of her death. Her reign of over 70 years is the longest of any British monarch and the longest verified reign of any female head of state in history. Elizabeth was born in Mayfair, London, as the first child of the Duke and Duchess of York (later King George VI and Queen Elizabeth The Queen Mother). Her father acceded to the throne in 1936 upon the abdication of his brother Edward VIII, making the ten-year-old Princess Elizabeth the heir presumptive.

Charles III as Charles Philip Arthur George born 14 November 1948 is King of the United Kingdom and 14 other Commonwealth realms. Charles was born in Buckingham Palace during the reign of his maternal grandfather, George VI, and was three years old when his mother, Elizabeth II, acceded to the throne in 1952, making him the heir apparent. He was created Prince of Wales in 1958 and his investiture was held in 1969. He was educated at Cheam School and Gordonstoun, and later spent six months at the Timbertop campus of Geelong Grammar School in Victoria, Australia. After earning a history degree from the University of Cambridge, Charles served in the Royal Air Force and the Royal Navy from 1971 to 1976.

CARRYING INTEGRITY, PROFESSIONALISM AND ACCOUNTABILITY THROUGH POLITICAL LEADERSHIP



He is The Right Honourable, Member of Parliament and Leader of the Conservative Party since 2022. He is the first British Asian prime minister. He previously held two cabinet positions under Boris Johnson, lastly as Chancellor of the Exchequer from 2020 to 2022. Sunak has been Member of Parliament (MP) for Richmond (Yorks) since 2015. Sunak was born in Southampton to parents of Indian descent who immigrated to Britain from East Africa in the 1960s. He was educated at Winchester College, studied philosophy, politics and economics at Lincoln College, Oxford, and earned an MBA from Stanford University in California as a Fulbright Scholar. During his time at Oxford University, Sunak undertook an internship at Conservative Central Office, and joined the Conservative Party. After graduating, Sunak worked for Goldman Sachs and later as a partner at the hedge fund firms The Children's Investment Fund Management and Theleme Partners. Sunak was elected to the House of Commons for Richmond in North Yorkshire at the 2015 general election. As a backbencher, Sunak supported the successful campaign for Brexit in the 2016 European Union membership referendum. Following the 2017 general election, Sunak was appointed to a junior ministerial position in Theresa May's second government as Parliamentary Under-Secretary of State for Local Government in the 2018 cabinet reshuffle. He voted three times in favour of May's Brexit withdrawal agreement, which was rejected by Parliament three times, leading to May announcing her resignation. During the 2019 Conservative Party leadership election, Sunak supported Johnson's successful bid to succeed May as Conservative leader and prime minister, after which he appointed Sunak as Chief Secretary to the Treasury in July 2019. Following the 2019 general election, Johnson promoted Sunak to Chancellor of the Exchequer in the 2020 cabinet reshuffle after the resignation of Sajid Javid. During his time in the position, Sunak was prominent in the government's financial response to the COVID-19 pandemic and its economic impact, including the Coronavirus Job Retention and Eat Out to Help Out schemes. He was also involved in the government's response to the cost of living crisis, UK energy supply crisis, and global energy crisis. Sunak resigned as chancellor in July 2022 amid a government crisis that culminated in Johnson's resignation. Sunak stood in the July-September Conservative Party leadership election to succeed Johnson. He had received the most votes in each of the series of MP votes, but lost the members' vote to Foreign Secretary Liz Truss.

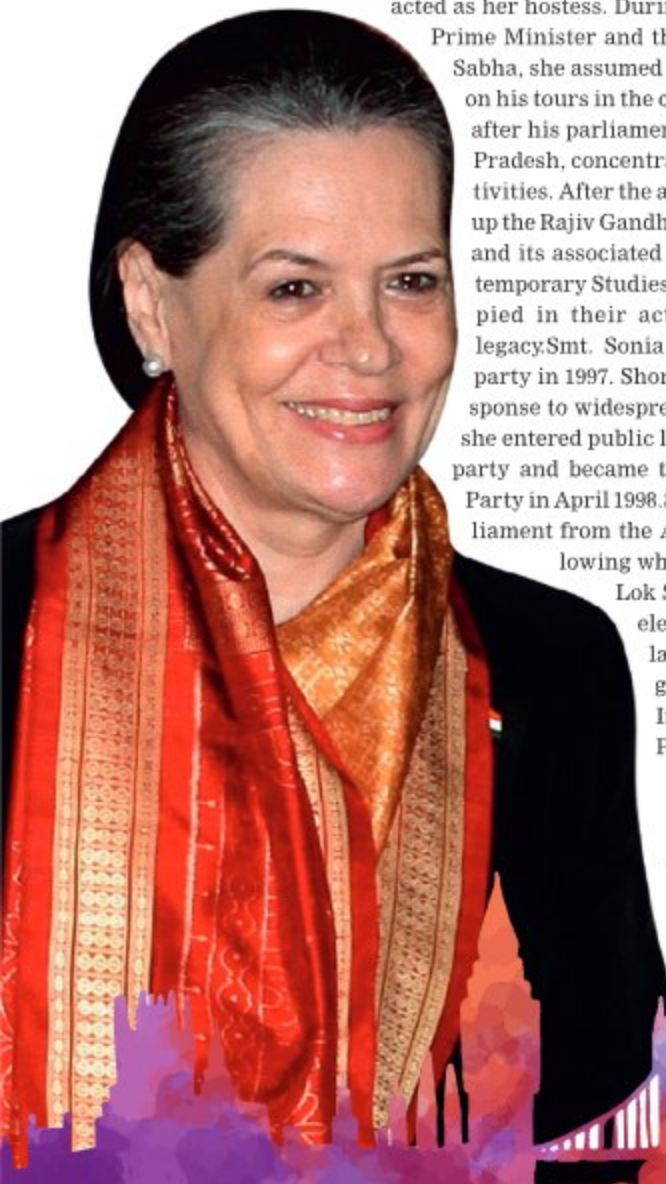

Smt. Sonia Gandhi was the longest serving President of the party, having been elected since 1998. She is also the Chairperson of the Coordinating Committee of the ruling coalition, the United Progressive Alliance. Smt. Gandhi was born on December 9, 1946. After her early education, she attended a foreign language school where she studied English, French and Russian. She met Shri Rajiv Gandhi in Cambridge where she was doing an English language course. They were married in New Delhi in 1968. She has a son, Shri Rahul Gandhi, a daughter, Smt. Priyanka Vadra, and two grandchildren. Smt. Gandhi spent most of her married life largely as a private citizen looking after her family. She was a companion to her mother-in-law, Smt. Indira Gandhi, during many of her official duties and frequently acted as her hostess. During the years 1984 to 1991 when her husband was

Prime Minister and then briefly leader of the Opposition in the Lok Sabha, she assumed a limited public role, mostly accompanying him on his tours in the country and abroad. At the same time, she looked after his parliamentary constituency, Amethi, in the state of Uttar Pradesh, concentrating on health-care camps and other welfare activities. After the assassination of her husband in May 1991, she set up the Rajiv Gandhi Foundation, a non-governmental organisation, and its associated think-tank, the Rajiv Gandhi Institute for Contemporary Studies. As Chairperson of these, she kept herself occupied in their activities which commemorate her husband's legacy. Smt. Sonia Gandhi took the primary membership of the party in 1997. Shortly before the Lok Sabha elections in 1998, in response to widespread demands from Congress party rank and file, she entered public life. She campaigned vigorously on behalf of the party and became the President of the Indian National Congress Party in April 1998. Smt. Gandhi was first elected as a Member of Parliament from the Amethi parliamentary constituency in 1999, following which she became Leader of the Opposition in the Lok Sabha. In the 2004 General Elections, she led the electoral campaign of her party which secured the largest number of seats. This enabled the Congress Party to form a coalition government (UPA). In this election, she was elected as a Member of Parliament from Rae Bareilly in Uttar Pradesh.

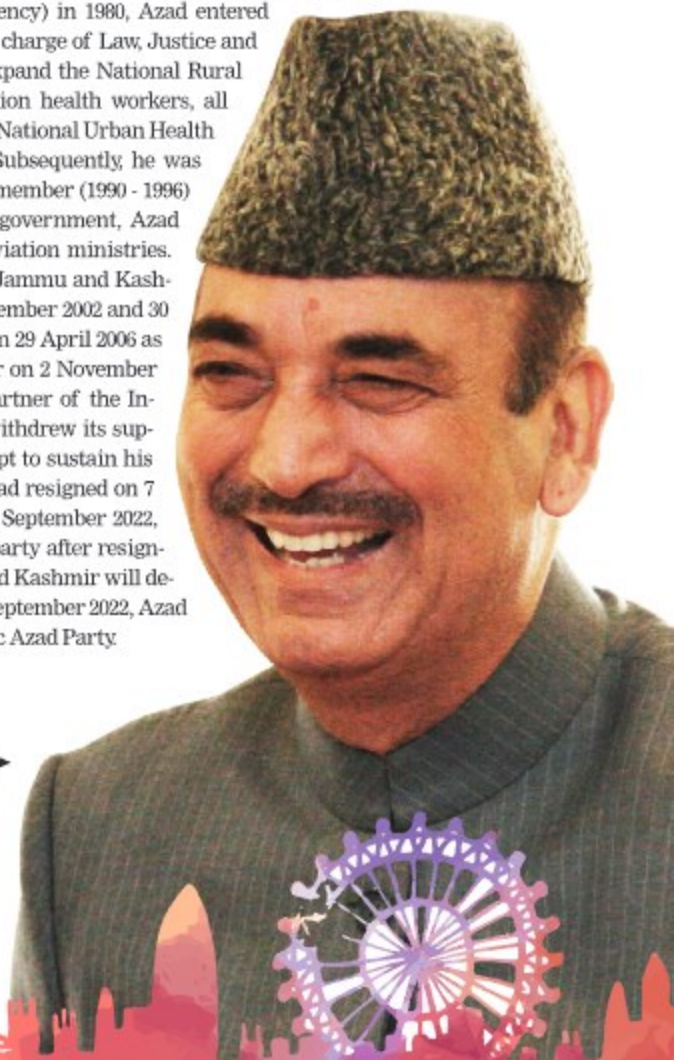

Ghulam Nabi Azad is an Indian politician who served as Leader of Opposition in Rajya Sabha between 2014 and 2021. He also served as the Chief Minister of erstwhile state of Jammu and Kashmir from 2005 to 2008. On 26 September 2022, Azad announced his own political party as Democratic Progressive Azad Party. He is the chief patron cum founder of Democratic Progressive Azad Party. Azad served as Minister of Health and Family Welfare. He served as the Minister of Parliamentary Affairs in the Manmohan Singh government until 27 October 2005, when he was appointed as the Chief Minister of Jammu and Kashmir. On 26 August 2022, Azad resigned from Indian National Congress and mulled creating a new party at the national level. He also led the party successfully in the 2002 Assembly election in Jammu and Kashmir. He was bestowed with the Padma Bhushan, India's third highest civilian award, in 2022 by the Indian Government in the field of Public Affairs. Azad started his career soon after working as the secretary for the Block Congress Committee in Bhalessa in 1973. Two years later, he was nominated as the President of the Jammu and Kashmir Pradesh Youth Congress. In 1980, he was appointed as the President of the All-India Youth Congress. After being elected to the Seventh Lok Sabha from Maharashtra's Washim (Lok Sabha constituency) in 1980, Azad entered into the Central government as Deputy Minister in charge of Law, Justice and Company Affairs Ministry in 1982. He vowed to expand the National Rural Health Mission, which has mobilized half a million health workers, all across India, and later his ministry also launched a National Urban Health Mission, to serve the slum dwelling urban poor. Subsequently, he was elected to the Eighth Lok Sabha in 1984 and was a member (1990 - 1996) from Maharashtra in Rajya Sabha. During Rao's government, Azad took charge of Parliamentary Affairs and Civil Aviation ministries. He was subsequently elected to Rajya Sabha from Jammu and Kashmir during the term of 30 November 1996 to 29 November 2002 and 30 November 2002 to 29 November 2008, but resigned on 29 April 2006 as he became Chief Minister of Jammu and Kashmir on 2 November 2005. The People's Democratic Party, a coalition partner of the Indian National Congress in Jammu and Kashmir, withdrew its support for Azad's government, and rather than attempt to sustain his government by requesting a vote of confidence, Azad resigned on 7 July 2008, and later left office on 11 July 2008. On 4 September 2022, Azad announced the formation of a new political party after resigning from Congress. He said the people of Jammu and Kashmir will decide the name and the flag for the new party. On 26 September 2022, Azad announced the name of his new party as Democratic Azad Party.

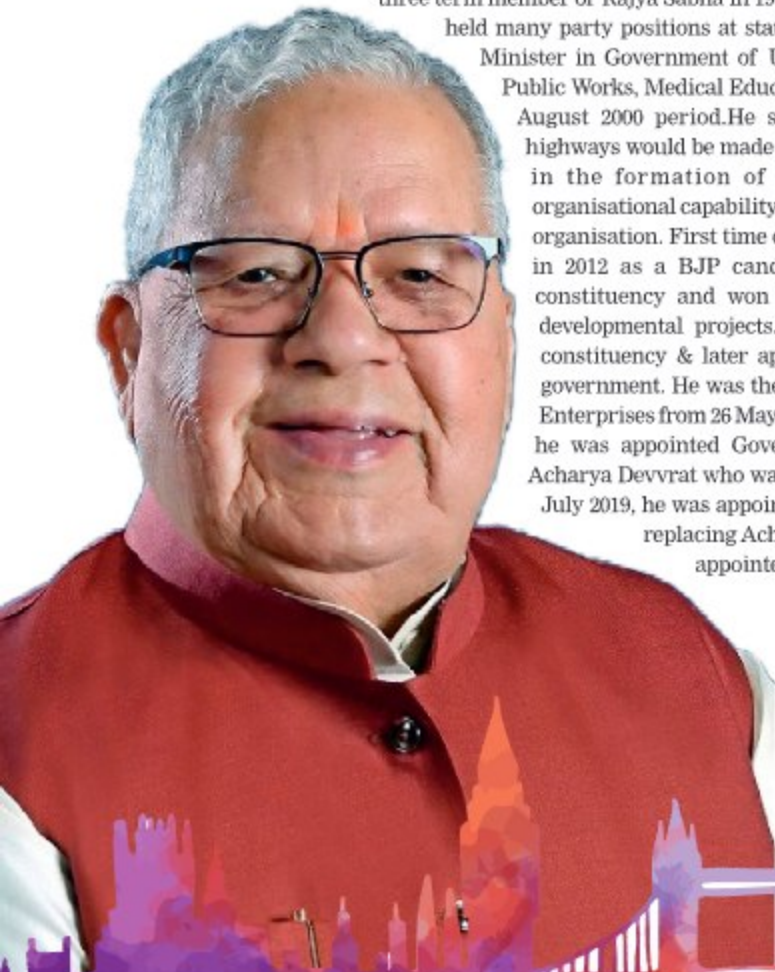

In 1977, he was vice-president of Janata Yuva Morcha (Youth organisation of Janata Party), with Subramanian Swamy as its president. In 1979, he was elected as President of Janata Yuva Morcha. He was the first elected National President of Bharatiya Janata Yuva Morcha. He was a three term member of Rajya Sabha in 1978, 2001 and 2006. He entered politics and held many party positions at state and national level. He was a Cabinet Minister in Government of Uttar Pradesh holding the portfolios of Public Works, Medical Education and Tourism during March 1997 – August 2000 period. He started a campaign wherein all state highways would be made crater free. He played an important role in the formation of Uttarakhand. By his efforts and organisational capability he was able to make a good & competent organisation. First time ever he contested Vidhan Sabha election in 2012 as a BJP candidate from Lucknow East assembly constituency and won the seat for BJP. He initiated many developmental projects. In 2014 he became MP from Deoria constituency & later appointed Cabinet Minister in the Modi government. He was the Minister of Micro, Small and Medium Enterprises from 26 May 2014 to 2 September 2017. Despite the threats of terrorists, was involved in the flag hoisting at Lal Chowk in Srinagar on 26 January 1992. She was a Member of Rajya Sabha, 1994-1998. In 1998, was elected from Mandal assembly constituency Ahmedabad, and became MLA. From 1998 to 2002, she was the Minister of Education (primary, secondary, and adult) and Minister of Women & Child Welfare. In 2002, became the legislator from Patan Vidhan Sabha constituency for the second time and proved the belief wrong that the Gujarat Education Minister cannot win consecutive elections. In the year 2007, became the legislator from Patan Vidhan Sabha constituency for the third time. From 2007 to 2012, she was the Minister of Revenue, Disaster Management, Road and Building, Capital Project, Women and Child Welfare. In the year 2005, the 'Patidar Shiromani' award was given her by the Patel community and was also honored by the Ambu Bhai Old School of Exercise, Rajpipla as well as awarded the "Charumathi Yoddha" Award.

Mr. Ramdas Athawale, Minister of Social Justice and Empowerment, Government of India has been an awardee of Dr. Bhimrao Ambedkar International Award 2023. He is Minister of State in the Ministry of Social Justice and Empowerment, Government of India since 2016 and represents Maharashtra in Rajya Sabha, the upper house of India's Parliament since 2014. Shri Ramdas Athawale was born on 25 December 1959 in Agalgaon, Sangli district, Bombay State, which is now Maharashtra. His parents were Bandu Bapu and Honsabai Bandu Athawale. He attended Siddharth College of Law, Mumbai and married to Seema Athawale, on 16 May 1992. He has a son. Ramdas Athawale is a practitioner of Buddhism. Athawale has been editor of a weekly magazine called Bhumika and is a founder member of Parivartan Sahitya Mahamandal. He has served as president of Parivartan Kala Mahasangha, the Dr. Babasaheb Ambedkar Foundation and the Bauddha Kalawant Academy (Buddhist Artists Academy) and was founder president of Bauddha Dhamma Parishad (Buddhism conference). He played the title role in a Marathi film, Anyayacha Pratikar, and also had a small role in another Marathi film, Joshi ki Kamble, as well as roles in Marathi dramas such as Ekach Pyala. Mr. Athwale was inspired by B. R. Ambedkar, the Indian polymath. Following a split in the Dalit Panther movement in 1974, Athawale joined Arun Kamble and Gangadhar Gade in leading a rump in Maharashtra. He favours increasing the prevailing 50 per cent quota that exists for government jobs and places at educational institutions to 75 per cent, stressing that this would apply to all castes that are recognised as economically disadvantaged, which includes those categorised at Other Backwards Classes. In May 2019, Athawale continued his position as Minister of State for Social Justice and Empowerment. Aside from his involvement in Dalit affairs; Athawale has also advocated reservation for economically disadvantaged upper caste communities. He has said that the government of India should release the caste-based information collected during the 2011 Census of India, which is considered to be a politically sensitive dataset, in order to address inequities in the reservation system across the board. He rejects claims that doing so would lead to an increase in casteism.

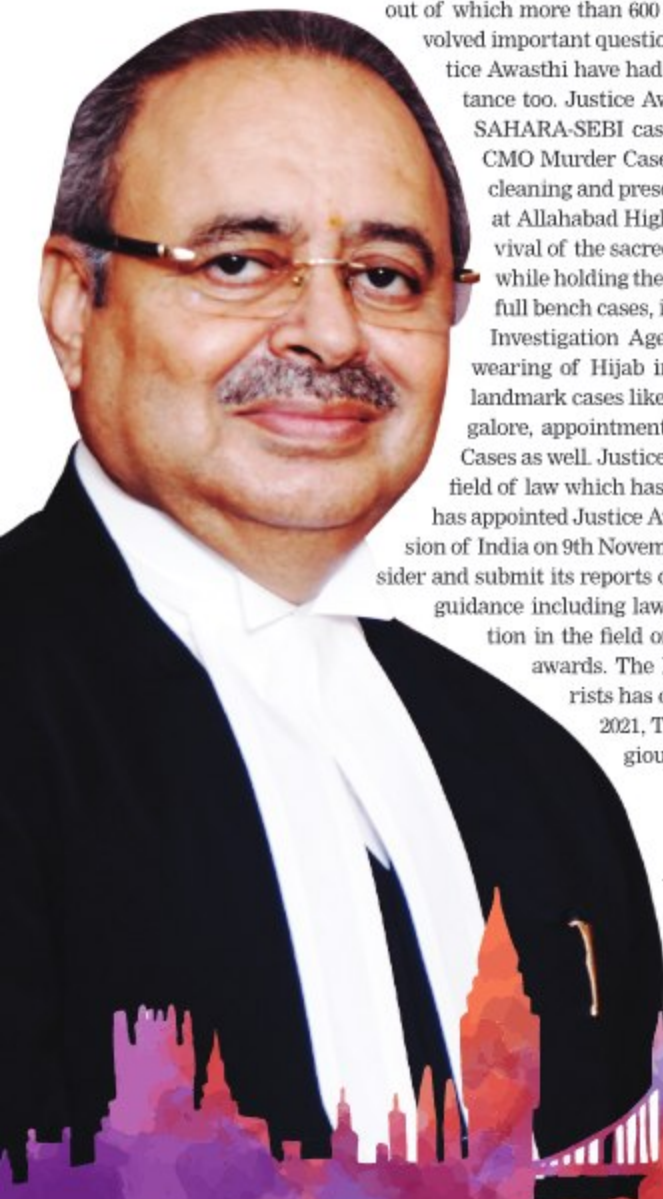

Hon'ble Justice Ritu Raj Awasthi, graduated in Law from Lucknow University in the year 1986 and enrolled as an Advocate on 1st February, 1987. He mainly practised in Constitutional Courts in Allahabad High Court at Lucknow Bench. He had also appeared as an Advocate in several cases in different High Courts and Supreme Court of India. He was appointed the Assistant Solicitor General of India for the Allahabad High Court in the year 2007. After practising for more than 20 years, he was elevated as High Court Judge on 13th April, 2009 and took oath as permanent Judge on 24th December, 2010. Hon'ble Justice Awasthi was also nominated as the Senior Judge of Allahabad High Court at Lucknow 05 January 2021 and thereafter was elevated as Chief Justice of Karnataka High Court on 11th October, 2021. During his tenure as a Judge for roughly 13 and half years, Hon'ble Justice Awasthi decided approximately 44,000 cases,

out of which more than 600 judgments were approved for reporting, as they involved important questions of Law. Most of the cases decided by Hon'ble Justice Awasthi have had nation-wide impact as well as international importance too. Justice Awasthi decided the matters related to NRHM Scam, SAHARA-SEBI case, Reservation in promotion case, CBI Enquiry in CMO Murder Case, etc. Justice Awasthi also issued directions for the cleaning and preservation of River Ganga in the Namami Gange Case at Allahabad High Court, which had a far reaching impact on the revival of the sacred river and making it pollution free. Justice Awasthi while holding the post of Chief Justice of Karnataka, decided various full bench cases, including those of Income Tax Matters and National Investigation Agency (NIA) case, mines and minerals and also the wearing of Hijab in schools case. Justice Awasthi also decided other landmark cases like Online Gaming case, issue of legacy waste in Mangalore, appointment of Public Prosecutors and important Arbitration Cases as well. Justice Awasthi has made a remarkable contribution to the field of law which has had far reaching impact. The Government of India has appointed Justice Awasthi as the Chairperson of the 22nd Law Commission of India on 9th November, 2022 and the Law Commission of India will consider and submit its reports on various crucial aspects under his leadership and guidance including law on Uniform Civil Code. Recognising his contribution in the field of law and public service he has been given several awards. The Indian Bar Association, and Indian Council of Jurists has conferred him National Law Day Award for the year 2021, The University of Lucknow bestowed him the Prestigious and Distinguished Alumni Award.

Dharmendra Kewal Krishan Deol is better known mononymously as Dharmendra, is an Indian actor, producer and politician who is primarily known for his work in Hindi films, as well as in a few Punjabi films. Sometimes nicknamed the He-Man of Bollywood, Dharmendra is widely regarded as among the most handsome Indian actors of his time. He received the Padma Bhushan, India's third highest civilian honour, from the Government of India in 2012. Dharmendra has worked in over 300 films in a career spanning over six decades. He is considered one of the most successful actors in the history of Hindi Cinema. After making debut in a small film, he first gained popularity in the mid 1960s for films such as Aaye Milan Ki Bela, Kaajal, Phool Aur Patthar, Aaye Din Bahar Ke among others. He then achieved greater stardom in later years, dubbed India's Garam Dharam for several of his on-screen roles in Hindi films. He consistently starred in top grossing Hindi films since late 1960s to 80s, such as Aankhen, Shikar, Aya Sawan Jhoom Ke, Jeevan Mrityu, Tum Haseen Main Jawan, Sharafat, Mera Gaon Mera Desh, Naya Zamana, Seeta Aur Geeta, Samadhi, Raja Jani, Jugnu, Yaadon Ki Baaraat, Kahani Kismat Ki, Loafer, Jheel Ke Us Paar, Keemat, Dost, Patthar Aur Payal, Sholay, Pratigya, Chupke Chupke, Charas, Maa, Dharam Veer, Chacha Bhatija, Azaad, Ram Balram, Kaatilon Ke Kaatil, Ghazab, Naukar Biwi Ka, Jeene Nahi Doonga, Ghulami, Hukumat, Insaniyat Ke Dushman, Loha, Aag Hi Aag, Elaan-E-Jung and Tahalka. He earned critical acclaim for his portrayal of a prison doctor in Bandini, a soldier in Haqeeqat, a writer in Anupama, a progressive husband in Majhli Didi and a righteous man in Satyakam. In the late 1990s, he began to appear in character roles in several successful and acclaimed films such as Pyaar Kiya To Darna Kya, Life in a... Metro, Apne, Johnny Gaddaar, Yamla Pagla Deewana and Rocky Aur Rani Kii Prem Kahaani. In 1997, he received the Filmfare Lifetime Achievement Award for his contribution to Bollywood.

A technical econometrics based model to study the embodiment of services in tradable goods was constructed. The data used was from the input output matrices of India and Canada. It was the first of its kind. Dr Trivedi retired as Shipping Secretary at the end of November 14th. Before joining the Shipping Ministry, Trivedi was heading the Inland Waterways Authority of India. He has also served as Secretary in the department of Social Justice and Empowerment and Mines. Trivedi has also worked as Special Secretary and Financial Adviser in the Ministry of Home Affairs among others. Under the social and cultural leadership of Dr. Trivedi, many mass wedding ceremonies were organized in Madhya Pradesh and other States of the country. When first elected, Shri Sharma served as a member of the International Development Select Committee, which after a five year hiatus he returned to in 2015. He was a member of the Health Select Committee from 2010 – 2015, along with membership of the Joint Committee on Human Rights. Since 2015 Virendra Sharma has returned to the Council of Europe where he is a member of the Sub-Committee on Refugee and Migrant Children and Young People. His father Dr Lekh Raj Sharma was a senior Congress Party Leader in Punjab (India) and an experienced politician. He was over 90 years old at the time of his death. He was a freedom fighter, remained member of Legislative Council of Punjab and Chairman of Jalandhar Improvement Trust. In 1996, he studied for a Master of Arts (MA) degree in Imperial and Commonwealth Studies at King's College London. Thomas was first elected to represent Harrow West at the 1997 general election when he defeated the incumbent Conservative, Robert Hughes, with a majority of 1,240 votes. He was appointed Parliamentary Under-Secretary of State at the Department for International Development in 2003. In May 2010 he was re-elected as Member of Parliament for Harrow West with a reduced majority (based on a notional 2005 result). He was Shadow Minister for Higher Education and Science from October 2010 to October 2011, Shadow Minister for Civil Society from October 2011 to October 2013, Shadow Minister for Europe from March 2013 to October 2014, then Shadow Minister for Africa and the Middle East from October 2014 to March 2015. At the 2015 general election the Conservative Party candidate Hannah David produced a significant swing from Labour to the Conservatives, reducing his majority to 2,208. Thomas received his worst general election result to date at the 2015 election. Thomas supported Emily Thornberry in the 2020 Labour Leadership Contest. He has served on the Official Opposition frontbench as Shadow Minister for International Trade since April 2020. He has been a recipient of many International Awards.

Indian-born British business magnate and philanthropist Lord Swraj Paul is well known as Baron Paul, PC. In 1996 he was appointed a life peer by Conservative Prime Minister John Major and sits in the House of Lords as a crossbencher with the title Baron Paul, of Marylebone, in the City of Westminster. In December 2008 he was appointed deputy speaker of the Lords; in October 2009 he was appointed to the Privy Council. Lord Paul has received various awards and honours including 15 honorary degrees from universities in the UK, US, India, Russia and Switzerland. In 1983 he was awarded the Padma Bhushan by Indira Gandhi, the then Prime Minister of India, and the Bharat Gaurav award by the Indian Merchants' Chamber; Freedom of the City of London, 1998; Asian Business Awards, Lifetime Achievement Award, 2008; Donald C. Burnham Manufacturing Management Award, Society of Manufacturing Engineers, USA, 1995; First Asian of the Year Award, Asian Who's Who, 1987; Asian Woman Magazine Lifetime Achievement Award, 2008. Power Brands Hall of Fame nominated him Global Indian of the Year, 2011. Massachusetts Institute of Technology, Corporate Leadership Award, 1989. Significantly, in 1966 he relocated to the United Kingdom to get medical treatment for his young daughter, who had leukaemia. He spent a year grieving her death, after which he founded Natural Gas Tubes. Starting with one steel unit, he went on to acquire more. This led to his founding the Caparo Group in 1968, which became one of the UK's largest steel conversion and distribution businesses, manufacturing an extensive range of structural steels, precision tube, spirally welded tube, special bar qualities, industrial wires, cold rolled strip and spring steel strip. Lord Paul stepped down from the management of the Caparo Group in 1996. Up until autumn 2015, Caparo employed over 10,000 people across North America, Europe, India and the Middle East. In October 2015, 16 of the 20 limited companies that formed most of Caparo Group UK collapsed into administration, and on 8 November his son Angad Paul, the Group's CEO, died in an apparent suicide from his eighth-floor penthouse flat. Lord Paul has held many public positions. He has been a recipient of many International Awards.

He was awarded an honorary doctorate from the University of West London in July 2016. Rami set up his first business in 1987 with a mere 2 pounds capital from a rented room in Hayes and through his sheer dedication and commitment, he now runs two of Britain's fastest-growing companies with an annual turnover over £150 million. He sustains thousands of British jobs by exporting British supermarket products to over 130 countries. Sun Mark Ltd has received the Queen's Award for Enterprise from Her Majesty the Queen for an unprecedented five consecutive years. No other British company has received this accolade to date. Ranger, through Sun Mark, had donated more than £1 million to the Conservative Party, and £25,000 to Theresa May's party leadership campaign. Ranger was appointed the joint chairman of Conservative Friends of India in 2018, sharing the role with then MP Zac Goldsmith. The group, which is affiliated to the Conservative Party, aims to build stronger links between the party, the British Indian community and India. He is a philanthropist, founder and executive chairman of clothing company Loomba Group, and a member of the House of Lords. Loomba was born as one of seven children in Dhilwan, in the state of Punjab, India. He was educated at D.A.V. College, Jalandhar and at the University of Iowa; his family moved to England in 1962. Loomba built up his fashion business from scratch, graduating from a stall at Widnes market to a shop, a wholesale business and then an import company, Rinku Group Ltd. The company has over 200 retail concession outlets in the UK, offices in London, Delhi and China, and supplies major retail groups. Loomba is a member of the Rotary Club in London, the Institute of Directors and is a Freeman of the City of London. He is Chairman of the Friends of the Three Faiths Forum, is Patron of Children In Need India, and is the Founding Patron of the World Punjabi Organisation. He is Vice President of Barnardo's and of the Safer London Foundation, a charity backed by the Metropolitan Police. In 1997 he was named Asian of the Year UK by Asian Who's Who International. Loomba is married to Veena Chaudhry, with whom he has two daughters and one son. On 12 January 2011 Loomba was ennobled as a life peer with the name, style and title of Baron Loomba, of Moor Park in the county of Hertfordshire. He took up his seat in the House of Lords on 13 January 2011, representing the Liberal Democrats. He was introduced to the House on 17 January 2011, supported by Lords McNally and Dholakia. On 21 January 2011 he gave his maiden speech in the House during a debate on the Rehabilitation of Offenders (Amendment) Bill. In December 2016, Lord Loomba left the Liberal Democrats and now sits as a non-affiliated Peer. Explaining his decision he said: "I now wish to concentrate on issues such as human rights, gender equality, education and above all the United Nations' 2030 Sustainable Development Goals" Loomba has become well known for his fundraising and campaigning concerning the issue of widowhood in the developing world. His mother, Shrimati Pushpa Wati Loomba, was widowed at the age of 37 in India, and Loomba experienced first-hand the social and economic discrimination that widows in that country faced. It was in his mother's memory that Loomba set up his charity, The Loomba Foundation, which works to raise awareness of the issue of widowhood and which raises funds to educate the children of poor widows in India and empower widows in other developing countries in south Asia and across Africa.

He is a British politician who has been the Member of Parliament (MP) for Harrow East since 2010. A member of the Conservative Party, he has served as the Joint Executive Secretary of the back-bench 1922 Committee since 2012. Blackman was the Member of the London Assembly (MLA) for Brent and Harrow between 2004 and 2008. Blackman unsuccessfully stood as the Conservative candidate in the Tokyngton ward of Brent London Borough Council in 1986. In 1990, he stood in the Preston ward and was elected; he retained the seat until 2010, when he did not stand. He was the leader of the Conservative group on Brent council from 1990 to 2010, having been council leader between 1991 and 1996, when his party lost control of the council. From June 2006 to May 2010, he was deputy leader of Brent Council, the Conservatives having formed a coalition with the Liberal Democrats. He unsuccessfully stood as the Conservative parliamentary candidate for Brent South at the 1992 election, for Bedford at the 1997 election, and for Brent North at the 2005 election. He stood as the Conservative Party candidate for the London Assembly constituency of Brent and Harrow at the 2000 elections, losing to the Labour candidate Toby Harris. He defeated Harris at the 2004 assembly elections and was elected as the Conservative group's whip on the London Assembly. After three maths A-levels Blackman studied maths and physics at the University of Liverpool and left with a Bachelor of Science degree. While at Liverpool, he was president of the students' union. He joined the sales team of Burroughs Machines (later Unisys) on graduation. He worked in various sales and management positions for BT and worked at their training school in Milton Keynes as a tutor and later as a regulatory compliance manager for BT until his election to Parliament. In 2016, he was drawn second in the annual Parliamentary ballot for a Private Member's Bill and put together a Homelessness Reduction Bill in partnership with national homelessness charity, Crisis. It was the first Private Member's Bill to be supported by a select committee. After receiving Government support at second reading, it passed through all stages in Parliament unopposed in both Houses and received Royal Assent on 27 April 2017.

Mr Navendu Mishra is the Labour MP for Stockport, and has been an MP continuously since 12 December 2019. He currently undertakes the role of Opposition Whip (Commons). He is of Indian ancestry; his mother is from Gorakhpur and his father is from Kanpur, both in Uttar Pradesh. He attended the public school Clifton College in Bristol. Before entering politics, Mishra was a shop-floor trade unionist in Stockport, eventually becoming an organiser for Unison and helping to organise care workers in precarious employment. Mishra was one of the founders of Stockport Momentum and supported Jeremy Corbyn in the 2015 and 2016 Labour leadership elections. He was a member of the Labour Party National Executive Committee from September 2018 until December 2019. As he was one of the nine representatives for Constituency Labour Parties, Mishra was ineligible to remain a member of the NEC upon his election as a Member of Parliament. Mishra unsuccessfully contested the seat of Hazel Grove (part of the Metropolitan Borough of Stockport) in the snap election of 2017, but achieved Labour's highest vote share ever in that constituency. He won 20.5% of the vote in a seat that has traditionally been a Conservative-Liberal Democrat marginal. He was selected as Labour's candidate for Stockport in the 2019 general election after the incumbent, Ann Coffey, left the Labour Party in protest over Jeremy Corbyn's leadership and joined Change UK. Mishra held the seat for Labour, with a 52% share of the vote. Mishra is a member of the Socialist Campaign Group and endorsed fellow SCG member Rebecca Long-Bailey in the 2020 Labour leadership election. On 15 October 2020, Mishra resigned as PPS to Angela Rayner to vote against the proposed Covert Human Intelligence Sources (Criminal Conduct) Bill, rebelling against the Labour whip to abstain. During the 2021 Batley and Spen by-election, Mishra accused his own party of having a "hierarchy of racism", with "some groups seen as fair game for attacks based on religion/ race/ heritage". He has been a recipient of many International Awards.

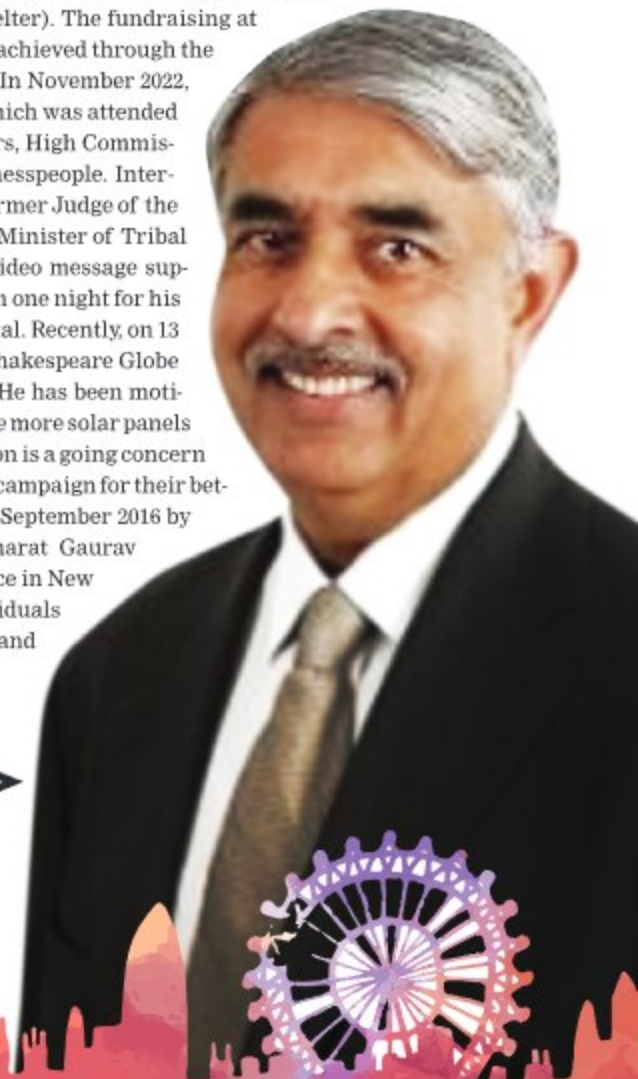

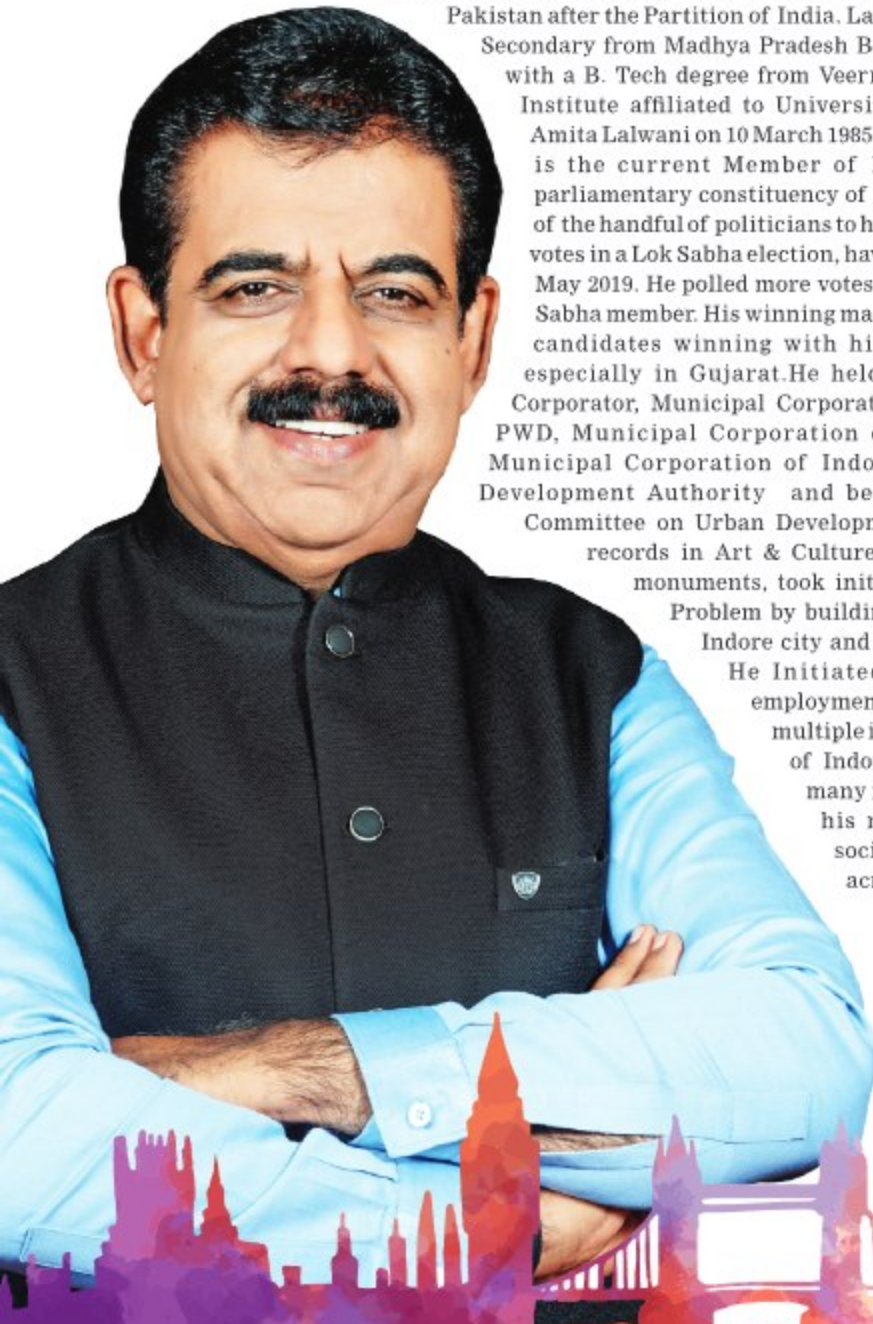

DEDICATED IN ENHANCING CAUSE OF SOUTHALL FOOTBALL CLUB

Southall FC is currently based at the Robert Parker Stadium in Stanwell, Surrey, approximately 8 miles from Southall. The club was founded in 1871, making it one of England's oldest football clubs. Southall FC's interest in taking over the facilities at Warren Farm has been endorsed by Labour MP for Ealing Southall Virendra Sharma. Sanjeev Sharma is the owner of the club. Warren Farm was used for sports pitches until the 1990s before falling out of use. In 2009 football club Queens Park Rangers considered acquiring the site for its training facilities in a partnership with Ealing Council which would have allowed some community use. Mr. Sharma has been very supportive to see Southall FC grow with some suggesting a "Sharma Stadium" is trying to be pushed through despite residents not wanting it at Warren Farm. He says that the most successful period for the club was between the 1920's up to the 1960's, when crowds numbering in the thousands regularly attended, especially for games against local rivals such as Hayes, Hounslow and Uxbridge and the club produced several Amateur Internationals and players that went on to join professional clubs during this period. For the big away games and important cup ties away from home coaches and trains were often chartered for the locals to follow the club's exploits. In 1925 Southall reached the Final of the FA Amateur Cup, when they narrowly lost to Clapton 2-1 at Mill wall FC in front of over 25,000 spectators and won the Athenian League title in 1926-27. Another momentous season occurred in 1935-36 when Southall recorded 17 consecutive cup victories in various competitions. During this season they became the first non-league club to start in the FA Cup Extra Preliminary Round and reach the 3rd Round Proper before finally losing to Third Division South professionals Watford in front of Western Road's record gate of 19,094. They also beat Third Division South club Swindon Town at home 3-1 in the FA Cup 1st Round. Their cup exploits that season meant that they had to play 23 matches between 1st April and 2nd May, which included 2 games on the same day twice! The club was forced to take the decision to sell their ground to the local Council in 1940 due to financial pressures during World War II and became tenants of the Council for the rest of that ground's existence. Southall have also played big Amateur Cup matches at Stamford Bridge, Highbury & Craven Cottage, all in front of over 20,000 fans. The club's last big cup day out was for the 1986 FA Vase Final at Wembley. In the 1970's and 1980's future full England Internationals Gordon Hill, Alan Devonshire, and Les Ferdinand played for Southall in their younger days.

Zoya Agarwal is an Indian commercial pilot who has flown for Air India. In 2021, Agarwal captained an all-woman crew making the inaugural flight from San Francisco to Bengaluru, one of the longest non-stop air routes in the world. In 2006, The Times of India highlighted Agarwal as a rising female aviator of India. She became the youngest woman pilot in India to fly a Boeing-777 in 2013. Agarwal garnered attention for her role in saving a passenger's life on a flight bound to New York in 2015. After a passenger complained of breathlessness, she decided to turn back the flight and land at Indira Gandhi International Airport, Delhi, where the passenger was taken to a nearby hospital. As a precautionary measure during the COVID-19 pandemic, the Government of India initiated Vande Bharat Mission in May 2020 to evacuate around 14,800 Indians from twelve countries on sixty-four Air India flights. Agarwal was chosen to co-pilot the first repatriation flight by the airline. In 2021, the crew made an appearance on Indian Idol for its Republic Day special episode. Later that year, Agarwal was chosen by the United Nations as its spokesperson for Generation Equality. In August 2022, Agarwal was commemorated by the U.S.-based San Francisco International Airport aviation museum for her career in aviation and for her promotion of women's empowerment. 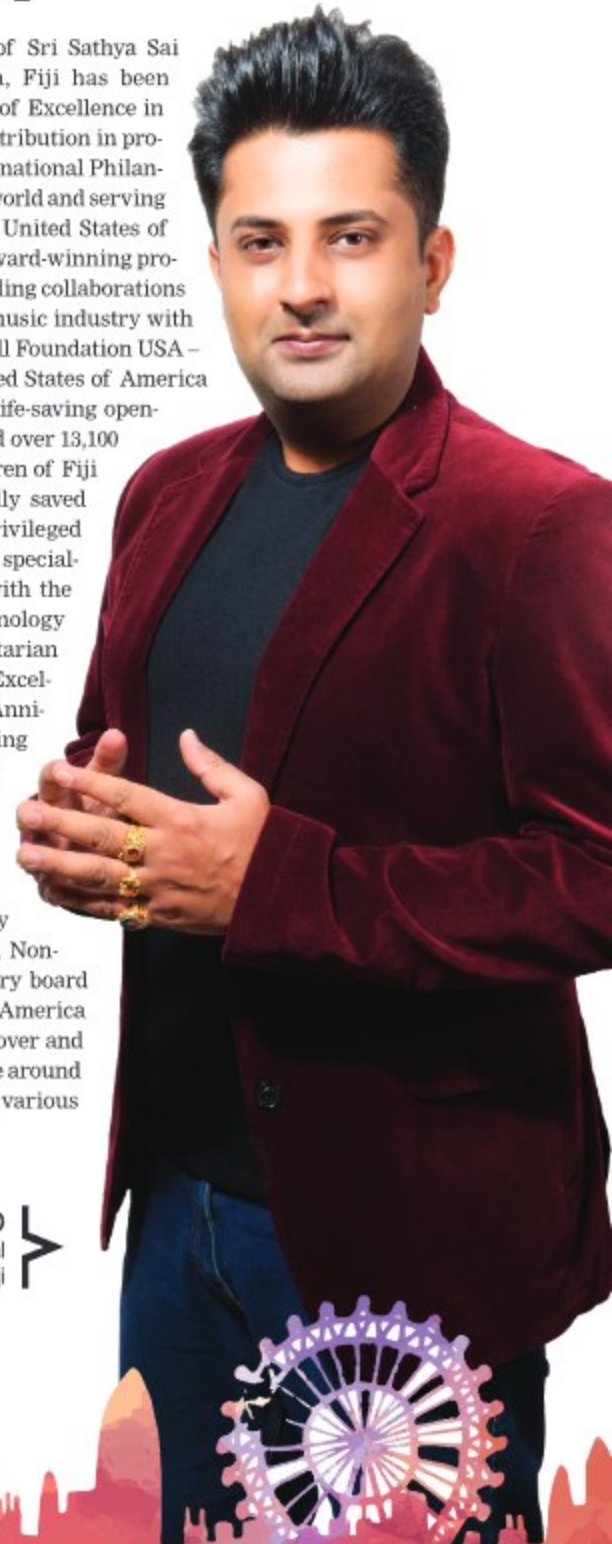

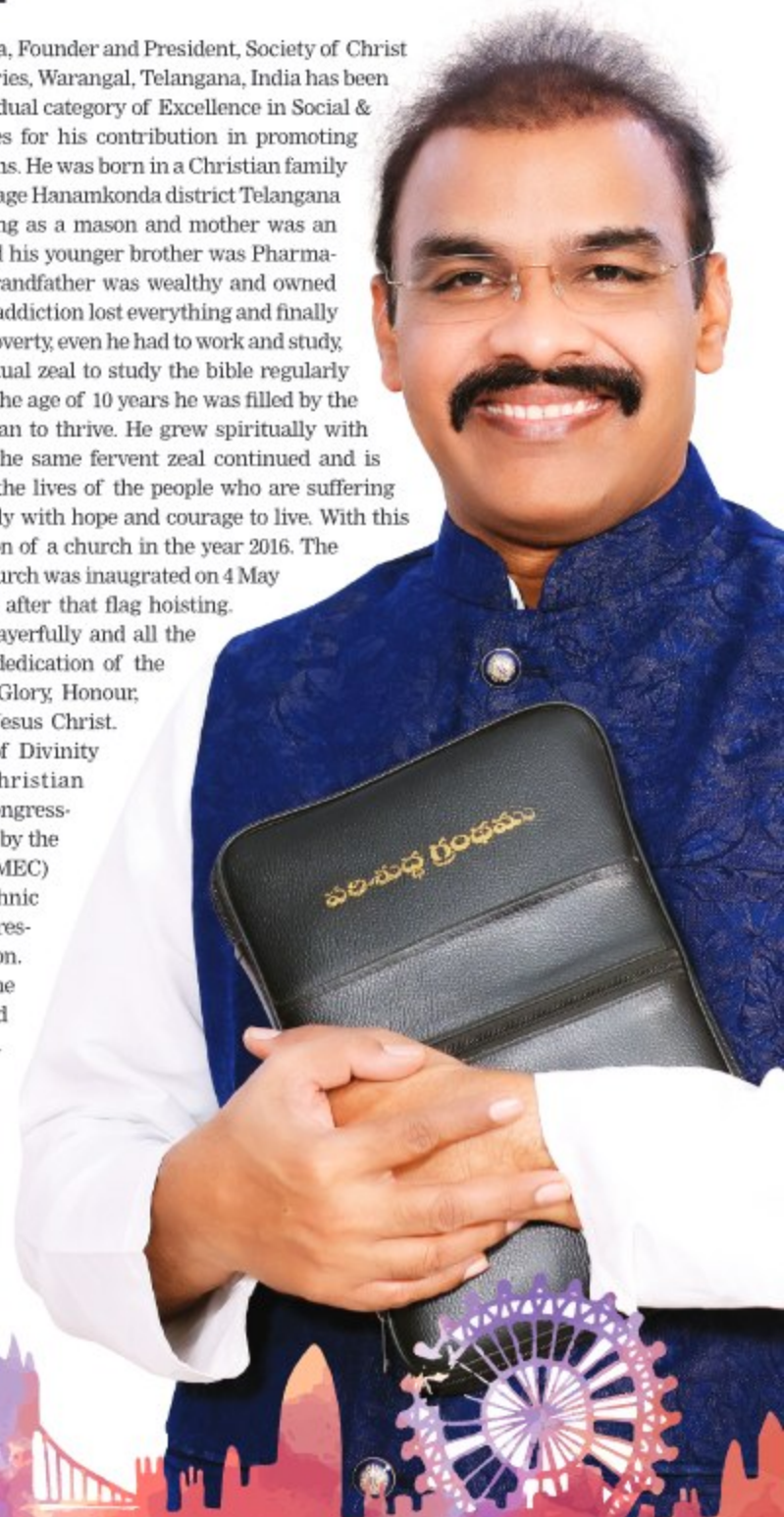
